Please read carefully these Terms and Conditions ("Terms") before using the website Enviro18.io, Enviro18.com & Seetoken.io ("Website") or buying Enviro18/SEE Token, as they affect your obligations and legal rights, including, but not limited to, waivers of rights and limitation of liability. If you do not agree with these Terms, you must not access or use the Website or buy Enviro18/SEE Token.

DEFINITIONS

Accompanying Documents shall mean other Enviro18/SEE Token Sale regulatory documents accompanying and detailing these Terms, being inalienable part hereof and published on the Website (including, but not limited to, Terms of Token Pre-Sale, Sale, or Memberships acquisitions and or purchases, Privacy Policy) effective at the moment of the Website use. In case of any discrepancies between Accompanying Documents and the Terms, the latter shall apply.
